## **Information Collected at [www.naperville.org](http://www.naperville.org)?**

The information we collect from NCUSD203 visitors and users of our Site allows us to personalize and continually improve your online experience, making it easier and more enjoyable. The following identifies the types of information we gather:

- **Automatic Information**  
We receive and store certain types of information whenever you interact with us. For example, like many Sites, we use "cookies," and we obtain certain types of information when your Web browser accesses our Site. Cookies are pieces of data your web browser stores on your hard drive to enable our systems to recognize you and your browser.
